

**SERVE UP THE HOLIDAY SPIRIT GIVEAWAY
OFFICIAL RULES – NO PURCHASE NECESSARY**

SWEEPSTAKES PERIOD/OVERVIEW: The Serve Up The Holiday Spirit Giveaway (the “Sweepstakes”) begins at 12:01 a.m. (all times are Eastern Time or “ET”) Wednesday, November 30, 2022, and ends at 11:59 p.m. on Friday, January 6, 2023 (“Sweepstakes Period”). There will be one (1) random drawing.

By registering via <https://pages.lactalisculinary.com/galbani-serve-up-the-holiday-spirit-sign-up/> sign-up, participants can enter for a chance to win an Ooni Pizza Oven Holiday Prize Bundle (Ooni Koda 16 Gas Powered Pizza Oven, a 14" perforated pizza peel, a 14" bamboo pizza peel, a turning peel and a cutter wheel). Once registered, participants will receive up to eight (8) emails throughout the Sweepstakes Period, each with an opportunity to receive a bonus entry for a total of nine (9) chances to enter. Sign up any time within the Sweepstakes Period to be eligible.

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR TO WIN THE SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

ELIGIBILITY: The Sweepstakes is open only to Food Service Professionals who are legal residents of the fifty (50) United States and the District of Columbia and as of date of entry are at least 18 years of age and the age of majority in their jurisdiction of residence (“Entrant”). Employees of Lactalis American Group, Inc. Reply to each original email within twenty-four (24) hours of the date and time the email is sent to you with your full name to receive one (1) “bonus” entry (“Bonus Entry”). All Bonus Entries must be received within twenty-four (24) hours of the date and time the email is sent by the Sponsor to be eligible.

Limit nine (9) Entries per person during the Sweepstakes Period. All Registration Entries and Bonus Entries submitted shall herein be referred to as the “Entry” or “Entries.” Any attempt by any Entrant to enter by using multiple/different email addresses, mailing addresses, identities, registrations and logins, or any other methods will void such Entries and that Entrant may be disqualified. Use of any automated or computer system to participate online is prohibited and will result in disqualification.
